Why has PCI DSS been introduced? PCI DSS council comprising of Visa Inc, MasterCard Worldwide, JCB International & Discover Financial Services have become increasingly concerned with the level of security protecting businesses' account and transaction information.

Who needs to become compliant? All merchants who banks, insurance, hotel, hospitals, store i.e. process or transmit cardholder data must comply with the standard.

Time-limited: Visa will require acquirers to provide an Attestation of Compliance Form for each of their Level 1 merchants demonstrating that each merchant has validated PCI DSS compliance by September 30, 2010. After this date, Visa will impose appropriate risk controls, up to and including fines, on acquirers that fail to provide an attestation form to Visa confirming that each of its Level 1 merchants has validated PCI DSS compliance.
